POLICY:

The Technical College System of Georgia (TCSG) and its associated Technical Colleges are committed to providing all employees, students, volunteers, visitors, vendors, and contractors with a safe and secure workplace and/or academic setting. Therefore, the possession, carrying, or transportation of a firearm, weapon, or explosive compound/material in the TCSG System Office or any Technical College campus shall be governed by Georgia state law. All individuals are expected to comply with the related laws.
