I. Academic Standards and Programs

Motion (Approval of Degrees, Diploma, and Technical Certificates of Credit):

Motion was made by Mrs. Anne Kaiser that the college requests listed below to offer degrees, diplomas, and technical certificates of credit programs be approved effective the semester specified for each request. Any fiscal requirements to begin these programs must be approved through the standard budget approval process. Motion was seconded by Mr. Ben Copeland and was unanimously approved.

Discussion:

Coastal Pines Technical College - (Waycross Campus) TCC program in Mobile Electronics Technician, ME61, 10 Credit Hours, effective February 2016.

This program is being added as a request from area high schools in order for CPTC to offer additional career paths in the electronics and electrical fields. The high school is interested in expanding its technology offerings and currently has 18 students interested in participating in this program. Coastal Pines Technical College requests to add this certificate as an option for students interested in careers in Electronics Technology and Electrical Systems Technology programs. No other colleges in or adjacent to the service delivery area offer this program. The program will offer the courses according to the state curriculum standard. The first year costs will be paid from tuition generated dollars. First year projected costs include: adjunct faculty salary - \$20,000; equipment - \$5000; supplies - \$4000; and travel - \$500. CPTC anticipates enrolling 15 students in the first year with a projected growth of at least 20 students by the third year.

Other benefits include reaching educational goals in less time and/or allowing students to work and provide for families while continuing their education in the associate's degree.

The Certified Funeral Celebrant certificate provides funeral homes with the option of expanding the types of services offered to bereaved families. Individuals will receive training in the areas of industry regulations and laws, general funeral home management, grief counseling and celebrant services. The goals are to prepare individuals to assist licensed funeral service professionals in providing funeral tributes that will celebrate and memorialize the deceased, while also providing care to the bereaved family and friends of a deceased. A graduate would work directly with the funeral director on the arrangements and elements of the service to provide a tribute that reflects the lifestyle and beliefs of the individual; meet with the family to offer guidance and consulting while planning a personalized and meaningful funeral to honor the loved one; conduct a Family Time for sharing of stories and memories; maintain a wide library of resources for readings, music and other special ceremonies to help the family design a service that honors the life. Other benefits include reaching educational goals in less time and/or allowing students to work and provide for families while continuing their education in the associate's degree.

• **Adult Education**

Ben Copeland

Mr. Ben Copeland gave the report for the Adult Education committee. He began by stating that all Board members should have received note about the recent changes to the GED pass rate. The previous pass rate was 150 or greater, and the new change in pass rate is 145 or greater. This effects over 1,900 Georgians who previously took the GED Test, and those changes grandfather in the test takers who took the test since January 1, 2014. He thanked Ms. Beverly Smith and her team for their tremendous work in contacting those individuals and for implementing the changes.

Mr. Copeland reminded the State Board of the upcoming EAGLE awards which will take place March 14-16, 2016 at the Grand Hyatt in Buckhead. One significant change this year is that the EAGLE award winner will receive a full-ride scholarship to one of our technical colleges.

The upcoming CLCP retreat will take place at Callaway Gardens March 30-31. This is the annual conference for the Certified Literate Community Program where communities participate in training.

That concluded the report for the Adult Education committee.

- **External Affairs and Economic Development**

Doug Carter

Mr. Carter began his report by giving a review of Quick Start; for the month of January they had five prospects for 675 potential new jobs and five job announcements for 1, 627 new jobs.

Mr. Carter stated that the annual Governor's Luncheon for Manufacturer's Appreciation Week will take place April 21, 2016 at the Georgia International Conference Center. Mr. Carter touched briefly on the 28th Annual Georgia Quail Hunt, hosted jointly by the Georgia Chamber, the Georgia Allies, the Albany-Dougherty Economic Development Commission, and Locate South Georgia. Mr. Carter shared that our own Commissioner, Gretchen Corbin, and State Board member, Anne Kaiser, are both on the host committee for that event that will take place February 10-12.

Mr. Carter remarked that the Office of Communications had several publications feature TCSG; three Atlanta Journal Constitution articles that include GED testing and scoring changes, a spotlight on Adult Education, as well as an article that highlighted Go Back Move Ahead.

Mr. Carter also gave a report on the 2016 Legislative Session. He stated that the AFY16 passed the House, and FY17 was to come up the following week. He stated that Travis Johnson, Assistant Commissioner for External Affairs, was doing a great job of tracking our agency legislation and the session was set to conclude on March 24, 2016.

Mr. Carter's last comment out of his committee was in reference to the Brenda Wise scholarship fund. He explained that staff from the TCSG foundation has been working with Ms. Wise's son on supporting the EAGLE award student with their fees and materials.

• **Governance, Compliance and Audit**

I. Motions

- a. Motion was made by Mr. Sully Sullivan to review and approve the proposed revised Mission Statement for Savannah Technical College. Motion was seconded by Mr. Tommy David and passed unanimously.**

Current Mission Statement:

Savannah Technical College is committed to meeting the dynamic education, academic, and workforce development needs of individuals, employers and communities through market-driven, environmentally-conscious education offered in the classroom, laboratory, community, and online.

Proposed Mission Statement:

Savannah Technical College, a unit of the Technical College System of Georgia, is a public, two-year college that provides world class education, skills training and lifelong learning opportunities through the delivery of associate degrees, diplomas, technical certificates of credit and non-credit economic development programs and adult education. The college is committed to meeting the dynamic education, academic, and workforce development needs of individuals, employers and communities

throughout the Coastal Empire with market-driven, environmentally-conscious education offered in the classroom, laboratory, community, and online.

b. Motion:

Motion was made by Mr. Sully Sullivan and seconded by Mr. Tim Williams to abolish **Policy IV.K: Cooperative Programs with Regents' Institutions**. The State Board voted and passed the motion unanimously.

Discussion:

The policy was originally adopted by the Board in 1985 prior to our institutions awarding associate degrees. As our colleges became SASCOC accredited this policy was needed for compliance with SACSCOC Comprehensive Standard 3.4.7. In 2012, the Standard changed such that the types of agreements covered by the Policy were no longer governed by the Standard. In addition, because our colleges are now accredited to issue AAS degrees and we have established articulation agreements with the Board of Regents [BOR], there is no need for the types of agreements contained in the Policy. The abolishment of the Policy will not impact current or future articulation agreements with BOR.

c. Motion:

Motion was made by Mr. Sully Sullivan to abolish **Policy V.B.2: Assessment**. Motion was seconded by Mr. Tommy David and passed the State Board unanimously.

Discussion:

The provisions of the Policy are repeated in the 2012 revision to State Board Policy V.B. Admissions. As such, a separate Policy is no longer required. TCSG will create a procedure to incorporate the requirement that colleges utilize a standardized assessment instrument which will also include the minimum testing scores for specific program admittance.

II. Local Board of Directors Update

• **Operations, Finance and Planning**

Dinah Wayne

I. Action Item (New Expenditures)

- Motion was made by Mrs. Dinah Wayne to approve the purchase of expenditure items or to execute requested contracts submitted by the system office and technical colleges. Motion was seconded by Mr. Sully Sullivan and passed unanimously.

1-2. Georgia Northwestern Technical College; total expenditure \$327,782.00 –

- 1) Purchase from CDW-G for network equipment to support a back-end infrastructure for virtual desktops in the classroom; cost \$161,929.00. **Local and bond funds are available for this expenditure.**

Discussion: This equipment will be for the college's network hub at the Walker County Campus and will allow for a full rollout of the VDI (virtual desktop) environment at the Catoosa County Campus, with the ability to expand the VDI technology across all campuses. The college's computer inventory is aging quickly and this will greatly reduce the overall cost of keeping student computer labs running with the latest technology. The purchase will include ACAD, Cisco, NetApp equipment and software for VDI infrastructure.

- 2) Purchase from Holston Gases Inc. to install/start up various pieces of Sole Brand welding equipment for welding program at Walker County campus; cost \$165,853.00. **Bond funds are available for this expenditure.**

Discussion: This purchase is part of the World Class Lab funds and will go toward replacing welding equipment that is in disrepair or outdated. It will allow for some expansion of the welding program into another classroom area allowing additional enrollment. This program is in high demand and graduating students are able to find work upon completion.

3. **Oconoe Fall Line Technical College – One HAAS VF-4 CNC machine with trunnion table and one HAAS CNC lathe from Phillips Corp. for Machine Tool Technology Program; cost \$206,951.00. **Federal grant funds are available for this expenditure.****

Discussion: These machines are needed to replace old and aging machinery that is 14 to 22 years of age. The two companies that have recently located to the service area use this type of machinery with these capabilities. This equipment will give the college the capability of training students to program and machines with complex parts they will see when they enter the workforce. The 2105 Predominately Black Institutions Competitive Grant is funding this purchase.

4. **Wiregrass Georgia Technical College; total cost \$1,246,472.00 – WGTC has recently constructed a new Allied Health and Public Safety Training Center at their Coffee County campus in Douglas, Georgia. The building will enable the college to provide new classroom space for new/expanding programs to support the Governor's strategic industry initiatives and the college's strategic plan. Programs housed in this building include Paramedic/EMT Laboratory, Practical Nursing, Pharmacy Tech, Medical Technician, Allied Health, and Criminal Justice. The Coffee campus hosts one of three firearms training simulators in Georgia. **Bond funds are available for these expenditures.****

- 4) Desktop computers, phone system and video conferencing equipment, network infrastructure/switching equipment, and servers from Adcap Network Systems to provide wired/wireless connectivity throughout the new building for faculty, staff and students; cost \$750,510.00.

- 5) Versteel tables from Ditto Sales (\$247,746) and 750+ chairs/seating from Seating, Inc. (\$248,216) for offices, classrooms, bookstore, library, and student lounge; total cost \$495,962.00.

II. Action Item (Items for Ratification)

- Motion was made by Mrs. Dinah Wayne and seconded by Mr. Buzz Law to ratify expenditure items/contract requests submitted by the system office and technical colleges. These were approved by the Commissioner during the December/ January time period when no State Board meeting was held. Motion was voted on and passed unanimously.
- 1. **Central Georgia Technical College** – One VentBoss Compact Collector and 8 portable welding vents from MSC Industrial Supply to update welding lab; cost \$139,754.00. ***Bond funds are available for this expenditure.***

Discussion: This purchase is part of an initiative of the Governor and State Office to provide additional equipment for specific program areas in association with the World Class Labs funding. This equipment is needed to update the ventilation in the welding lab and will help expand the college's welding program into part of the service area they were previously unable to fund. The system includes a sprinkler system and air monitor/exhaust for air quality.

Dinah Wayne, chair of the operations, finance, and planning committee, gave the report from her committee. She began by thanking the TCSG Board Chairman, Joe Yarbrough, for joining their committee meeting. She explained that Richard Young, Director of DPR, gave a report to their committee about enrollment which explained the while enrollment was down, the graduation rate from our colleges was up, and the Move on When ready numbers also showed a significant increase.

She stated that Deputy Commissioner, Matt Arthur, gave an update on the active shooter drills. As a reminder at the December meeting, goals were set for one campus from each TCSG college to complete an ASD or multi-discipline exercise during 2014 and 2015, and that goal was reached. She thanked Donna Burns and her team for their hard work. At the December meeting the OFP committee requested that all campuses complete a multi-discipline exercise in three years, as opposed to the six or eight years that was proposed. Matt Arthur, Linda Osborne-Smith, and Donna burns created a schedule that states all campuses will complete a drill by 2018. Current full-time and adjunct faculty, staff and students will receive training in active shooter response and will participate in practice exercises.

That concluded Mrs. Wayne's report.

• Executive Committee

Chairman Yarbrough

The Chairman thanked Matt Arthur, Linda Osborne-Smith, and Donna Burns for their diligence in creating a plan for these active shooter exercises so that all of our colleges may remain safe and prepared in the face of an emergency.

He mentioned Dr. Lynn Cornett's absence in the committee meeting, but explained that she called into the meeting to participate. He went on to elaborate on a few scheduling changes. First was the date change of the April Board meeting. It will now take place on April 18. The meeting will follow a regular schedule for that Monday, but the date was changed to allow and encourage Board member participation at the annual TCSG Leadership Summit that takes place at the Grand Hyatt.

He then thanked Commissioner Corbin for the outstanding budget presentation that she gave during the Committee of the Whole. He thanked the Governor and the TCSG leadership team for the diligence and commitment to TCSG and the system's mission of creating a workforce for Georgia.

He explained that during the executive committee the group discussed the process for how committee members request additional information from the TCSG staff. The Chairman reminded all Board members that the Committee Chairperson should be asked for any additional information, and the Chairperson would then communicate with the appropriate Assistant Commissioner to obtain the information and prioritize the request. This will allow the TCSG staff to continue to do the good work for the system and the students.

That completed Chairman Yarbrough's report.

IV. COMMISSIONER'S COMMENTS

Commissioner Gretchen Corbin

Commissioner Corbin began her report by thanking each technical college for the assistance during the 2016 legislative session and for supporting the entire system and the TCSG team. She thanked Travis Johnson for his work and for keeping the entire system on the same page.

There have been several new additions to the TCSG team:

- Dr. Scott Rule: Assistant Commissioner for Data, Planning, and Research. Dr. Rule comes to us from Chattahoochee Technical College where he previously served as Vice President for Student Affairs and Technology. He joined the team on January 19.
- Ms. Courtney Ware: Director of Human Resources. Ms. Ware joins our team from the Department of Juvenile Justice where she previously served as Deputy Director of Human Resources. She joined our team on January 4.

The Commissioner echoed the sentiments of Mr. Ben Copeland regarding the recent changes to the GED pass rate. The Commissioner once again thanked Beverly Smith and her team for their work, and also stated what a positive change this will continue to be for our adult education learners.

That concluded the Commissioner's report.

V. OTHER BUSINESS

Chairman Yarbrough

Chairman Joe Yarbrough had two other items of business. One was to alert the State Board to the resignation of Mr. Jack Winter. He resigned from the State Board to pursue other ventures. Chairman Yarbrough thanked him for his service and his dedication to the Board for many year, and wished him well in the future.

Lastly he reminded the Board that the next meeting of the TCSG State Board would take place on Wednesday, March 3 at the Georgia BioScience Training Center in Social Circle, Georgia.

The Chairman asked for a motion to adjourn; motion was made by Mr. Ben Copeland, seconded by Mr. Tommy David, and the meeting was adjourned at 1:50 p.m.
