Albany Technical College as well as two other colleges had damage from the storm and he is working with the State to help get our student back in the classroom as soon as possible.

GEMA has requested assistances and 12 of our colleges have been able to help. I. <u>Academic Standards and Programs</u>

Motion (Approval of AAS Degrees):



The motion was made by Dr. Lynn Cornett that the college requests listed below to offer AAS degree programs be approved effective the semester specified for each request. Any fiscal requirements to begin these programs must be approved through the standard budget approval process. The motion was seconded by Mr. Ben Copeland. The Board voted and the motion was unanimously approved.

# **DISCSSION:**

Savannah Technical College - Degree program in AAS in Interdisciplinary Studies, AF53, 61 Credit Hours, effective November 2018 The Associate of Applied Science Degree in Interdisciplinary Studies (AIS) allows customization of the program of study based on each student's academic and professional goals. The AIS requires completion of 61 semester credit hours (21 hours of general education requirements and 40 hours distributed among one or more areas of emphasis). Areas of concentration include education, public safety, business and computer/information technology, industrial/engineering technology, and health sciences. The program curriculum may be strategically selected to build upon the student's goals and objectives. Learning opportunities develop academic and professional knowledge and skills required for job acquisition or continued education. A student might choose an interdisciplinary studies program if his or her specific goals and interests cannot be met through a school's existing majors, minors and electives. This program will also help address the needs of employers in the area to upskill their workers with supervisory and managerial skills which will enable graduates to progress within the workplace.

Wiregrass Georgia Technical College - Degree program in AAS in Interdisciplinary Studies, AF53, 61 Credit Hours, effective January 2019 Wiregrass Georgia Technical College is requesting the approval of the Associate of Applied Science in Interdisciplinary Studies allowing customization of the program based on each student's academic and professional goals. A survey was conducted and 68% of respondents expressed a need for an advanced degree for upward mobility. The Interdisciplinary Studies Associate of Applied Science is a state standard



program, and implementation of the program will adhere to all guidelines set forth by the State Board of the Technical College System of Georgia. There are no additional funds associated with beginning this program as existing faculty and facilities will be utilized. The first year's enrollment is estimated to be 50 students, growing to 100 students in the third year.
