## Eligibility

- **OSY versus ISY**
  - Low Income Requirement
- **Low-Income Determination**

# Youth Resource Guide Content

## Eligibility

- **Acceptable Documentation**
  - Self-attestation
  - School Section 504 records provided by the participant
  - Assessment test results

# Youth Resource Guide

## Eligibility

- **Victims of Human Trafficking**
  - Under the Trafficking Victims Protection Act (TVPA) WIOA Services cannot be denied based on immigration status
  - Eligibility and Documentation
  - WorkSource Georgia Academy Training on Human Trafficking

# Youth Resource Guide

## Eligibility

- **Priority of Service and Jobs for Veterans State Grants Act**
  - For priority of service, “Veteran” means a person who served at least one day in the military and was discharged under conditions other than dishonorable.
