II. COMMISSIONERS COMMENTS

Commissioner Gregory Dozier

Commissioner Dozier thanked everyone for calling in today. He gave an overview of the current aviation programs offered at TCSG. The System went through a reauthorization due to changes with the FAA rules. The FAA went through all the Aviation Programs at TCSG. Most of the programs were good, but a few programs had some small changes that needed to be made. One of the change is to purchase a piece of training equipment that is currently on loan at Augusta Technical College. The purpose of this special meeting is to procure this piece of equipment for the College. The aviation program at Augusta Technical College should be back up and running very soon with the changes we have made and with piece of equipment, that is



currently on loan, and will have funds approved to purchase this item after this meeting if approved.

Dr. Jermaine Whirl, President at Augusta Technical College, thanked the State Board Members. He let the Board know that the POs were submitted for this purchase about two months ago, but they have been working with the vendor to get everything on one PO. III. DISUCSSION ON EXPENDITURE REQUEST

Chairman Sheppard called on Mrs. Penni Haberly, Assistant Commissioner of Administrative Services, for her comments.

Mrs. Haberly reviewed the equipment purchase item. Augusta Technical College is asking to purchase Aviation maintenance training systems from Avotek for the Aviation Program at a cost \$207,436.00. This purchase has already gone through the procurement process and was posted for bids. There were no disputes on the purchase. This will be purchased with federal grant funds.

IV. NEW EXPENDITURE REQUEST MOTION

MOTION: Mr. Carvel Lewis made the Motion for the State Board to authorize the Commissioner to purchase the designated items or execute the requested contracts for the Technical College listed below at a cost not to exceed the amount stated. Mr. Mark Hennessy seconded the Motion. The Motion passed State Board approval unanimously.

1. Augusta Technical College – Aviation maintenance training systems from Avotek for the Aviation Program; cost \$207,436.00. Federal grant funds are available for this expenditure.

DISCUSSION: This purchase is for multiple aviation training systems that bring simplicity/modernization to the student. With live running components, it aids in visualization and trouble shooting skills that are standard for today's aviation requirements. A new curriculum has been established for FAA Aviation Schools to



begin instruction. This equipment is needed to meet the new curriculum requirements in the Aviation Program and to allow the college to operate under the new guidelines. Equipment includes E47, E45, AS86, F51, F52, AL26, and AE42-12D maintenance trainers.
