I. WELCOME AND CALL TO ORDER

I. Approval of the Minutes

MOTION: Mr. Jay Cunningham made the Motion to approve the March 2, 2023 minutes. Mr. Doug Carter seconded the Motion. The Motion passed State Board approval unanimously. The March 2, 2023 Minutes were approved.

<u>Academic Affairs</u>

Daren Wayne for Fran Miller

I. Academic Standards and Programs

Motion (Approval of Degrees, Diplomas, and TCC):

MOTION: Mr. Daren Wayne made the Motion that the college requests listed below to offer degrees, diplomas and TCCs programs be approved effective the semester specified for each request. Any fiscal requirements to begin these programs must be approved through the standard budget approval process. Dr. Artesius Miller seconded the Motion. The Motion passed State Board approval unanimously.

DISCUSSION:

Atlanta Technical College - TCC program in Natural Gas Technician, NGT1, 14 Credit Hours, effective May 2023.

According to the Bureau of Labor Statistics, 2021 employment data for the State of Georgia included approximately 1,500 jobs related to this certificate, including 160 jobs for Gas Plant Operators (51-8092) and 1,420 jobs for pipe layers (147-2151). Data specific to natural gas technicians is not available. However, an Internet search for job postings in November 2022 yielded 68 vacant positions in the state. This program will support workforce needs at companies such as Atlanta Gas Light, Georgia Natural Gas, Georgia Power, Gas South, SCANA Energy, Southern Company, Walton EMC, and other residential and commercial gas line and piping companies.

Central Georgia Technical College - TCC program in Firefighter I, FF11, 15 Credit Hours, effective August 2023.

The Firefighter I TCC program is conducted in cooperation with the Georgia Fire Academy and Georgia Firefighter Standards and Training to ensure graduates have the skills, knowledge, and credentials to serve as firefighters in paid and volunteer fire departments. Due to a shortage of qualified firefighters, Macon-Bibb County Fire Department and William S. Hutchings College and Career Academy (Bibb County) have developed a partnership with CGTC to offer this Firefighter I TCC to dual enrollment students. The program will give the dual enrollment students the opportunity to interview with the Macon-Bibb County Fire Department. South Georgia Technical College, which is adjacent to CGTC's service area, currently offers this certificate. This is a state standard program and meets State Board requirements for programs at the certificate level. Startup cost for this program is estimated at \$4000 for adjunct stipend and library resources. All necessary equipment will be furnished by the Macon-Bibb County Firefighter Training Academy. Enrollment is estimated to be 15 graduates the first year and increase to 20 graduates by year three. Enrollment estimation is based on student interest.

Coastal Pines Technical College - TCC program in Emergency Medical Responder (EMR), EB71, 11 Credit Hours, effective August 2023.

Coastal Pines Technical College has two dual enrollment partners, Camden County High School and Jeff Davis High School, who have requested the addition of the Emergency Medical Responder program. The high schools are interested in offering the Emergency Medical Responder Technical Certificate of Credit program through dual enrollment. The dual enrollment partners have 32 students interested in the program. The Camden County EMS is also a partner in the program with Camden County High School and has 14 current openings, with additional openings expected at a reported entry-level annual salary of \$38,000. The Jeff Davis Hospital has offered support for the program by providing a qualified adjunct faculty member to teach the program, and the hospital agrees to assist with lab activity needs. There is one adjacent technical college that offers this program, and the program will follow the TCSG standard curriculum for a technical certificate of credit. The first-year costs will include salary, benefits,



supplies, and equipment at a total of \$14,295 for 32 students, and year three will have the same expense with an estimated 35 students enrolled.

Gwinnett Technical College - Diploma program in Diesel Equipment Technology, DET4, 47 Credit Hours, effective August 2023.

Gwinnett Technical College is requesting to add the Heavy Diesel Technology diploma to its program offering to continue to develop diesel technicians for the College's service area. This diploma would build upon the College's highly successful and popular Heavy Diesel certificate program (HD31). Students would have the option to complete a certificate or diploma program, depending upon their career goals and aspirations. Local business and industry support this diploma program as it has basic English and math courses needed for communication and calculations in the industry and maintains the internship course which provides vital hands-on opportunities for students. The costs associated with the program are minimal, as existing faculty, resources, and classrooms will be used. Over time, if enrollment grows substantially, future faculty will be needed, but tuition revenue should cover that expense. We expect eight students to enroll the first year, with enrollment growing to 27 by year three. We anticipate some former certificate program graduates will return to complete the diploma for advancement within the industry.

Gwinnett Technical College - TCC program in Hybrid/Electric Vehicle Service Technician, HVS1, 19 Credit Hours, effective August 2023.

The Hybrid/Electric Vehicle Service Technician certificate will fill a gap in program offerings and support numerous businesses in the Gwinnett Tech service area. The automotive industry is shifting towards a greener future with the increased use of hybrid and electric vehicles. The U.S. House and Senate recently passed the Inflation Reduction Act that offers a federal rebate to both new and used electric vehicles. As these vehicles become more mainstream, skilled technicians are needed to service and maintain them. Ford Motor Company announced two different divisions with Ford Blue covering hybrid and electric models, which are



projected to be 50% of the market by 2030. Gwinnett Tech needs to remain cutting edge and increase opportunities to train new technicians, as well as update the skillset of current technicians to service hybrid and electric vehicles. This TCC is unique in that it allows all of our manufacturer programs the opportunity to participate and increase students' knowledge and skills. No other TCSG college has programs like Mopar CAP, the Mercedes-Benz College Program, or Ford ASSET. As such, this is an institutionally created program. The costs for this program seem higher than they are since the salaries are already paid to existing faculty, and no new faculty will be needed. Additionally, larger startup costs are needed to secure vehicles to support this program, though used vehicles will be purchased where available. The College's automotive building has older electrical systems, so some of the initial costs are to increase electrical capacity in the lab to handle electric vehicles. A new transformer and service that can support this load are being installed now. We anticipate a full class of 20 students by the end of year three once the community becomes aware of the program and its opportunities.

Gwinnett Technical College - TCC program in Natural Gas Technician, NGT1, 14 Credit Hours, effective May 2023.

This request was previously ratified by the State Board at the February meeting. The effective date is now being changed from August 2023 to May 2023, which needs State Board approval. The Natural Gas Technician certificate program has been developed in collaboration with Atlanta Gas Light and the Technical College System of Georgia. This will become a state standard program that will provide an entry-level trained workforce to support the gas utility industry primarily in the Metro Atlanta region. According to 2021 data from the Bureau of Labor Statistics, annual mean wages for related positions range from \$37,100 to \$61,830. (\$17.84 to \$29.73 hourly). For entry-level positions, annual wages range from \$23,230 to \$39,520 (\$11.17 to \$19.00 hourly). Graduates will have opportunities for career advancement with additional work experience, training, and/or education. First-year costs for this program will be funded from tuition revenue; they are estimated to be \$39,400 for instructional equipment and faculty salaries. Gwinnett Technical College projects that enrollment will grow from 15 students in year one to 30 students in year three.

Southern Regional Technical College - TCC program in Film Production - Grip & Rigging Technician I, FP31, 12 Credit Hours, effective May 2023.

Southern Regional Technical College is seeking approval for the Film Production -Grip & Rigging Technician I (FP31) technical certificate of credit. The Film Production - Grip & Rigging Technician TCC is an institutionally developed program from Southern Crescent Technical College and is 12 credit hours in length. The completion of the TCC will prepare students for entry-level production assistant positions assigned to the Grip/Rigging department in film, TV, video, or other media companies. These skills will also allow them to operate in a variety of professional production environments and understand the jobs, protocol, and hierarchy of this demanding work. Employment in media communication and film production is projected to grow 14% over the next 10 years, which is much faster than the average for all occupations. The program will be taught at Colquitt County High School using their lab facilities and equipment. No additional equipment or faculty will be needed.

Adult Education

Mr. Daren Wayne gave the Committee report. Dr. Cayanna Good shares that the adult education program has around 32,000 students enrolled. NRS students are around 23,000 students. IET enrollment is 1,078. HSE graduates are 4,759 with a goal of 7,710. 44% of our HSE graduates were Adult Education students.

I. Motion to approve GED testing fees

II. Motion to approve the HDCI Program and development of contracts



MOTION: Mr. Daren Wayne made the Motion to approve the companies as listed for participation in the High Demand Career Initiatives (HDCI) Program and authorize the development of contracts with selected companies for contract completion awards. Mr. Doug Carter seconded the Motion. The Motion passed State Board approval unanimously.

DISCUSSION:

Today, we are considering the second round of program awards for the High Demand Career Initiatives (HDCI) Program, which will award out the remaining funding for Fiscal Year 2023.

Last year, the HDCI Program, authorized by Georgia Senate Bill 379, was signed into law by Governor Brian P. Kemp. As Georgia's first-ever state-funded apprenticeship initiative, the HDCI Program represents a historic investment by the State of Georgia in the expansion of registered apprenticeships.

The HDCI Program provides funding awards to Georgia employers to incentivize the creation and expansion of registered apprenticeship programs throughout the state. This program aimed to both upskill Georgians and increase skilled talent within Georgia's high-demand industries.

This round of HDCI funding will support an additional 10 employers and create 34 apprentices in Georgia. Year-to-date, this program has supported 39 employers, and created 125 apprentices throughout the state. The state's initial investment of \$1.275M for this program is projected to create \$7.39M in added wages into Georgia's economy year over year upon the completion of the apprenticeships supported with this year's funds.

<u>External Affairs and Economic Development</u>

Chunk Newman

Mr. Chunk Newman gave the Committee report. In March 2023, the Quick Start team presented to eight different prospects representing a total of 3,256 potential new jobs for Georgia. Industries represented by these prospects include automotive, packaging/warehousing, and clean tech manufacturing.

During March 2023, Quick Start delivered instruction to 3,742 trainees (new and existing employees). QuickStart had several project kick-offs this month around the State.



The TCSG Communication department completed the 2022 TCSG Annual Report and each Board Member should have a copy at their desk. The Communication Team launched a statewide digital marketing campaign promoting the benefits of technical education earlier this month. So far, this campaign has delivered **370 applications** to our 22 colleges. This digital strategy is being executed by TCSG through CoxNext.

The Communications Team is assisting the Workforce division with a digital marketing strategy promoting the Apprentice Georgia program. The campaign launched last week and is collecting inquiry leads from both companies and individuals.

TCSG and GaDOE are finalizing paperwork on the winning bid for our upcoming joint marketing project to promote technical education and CTAE courses in high school.

Mr. Mark Peevy updated the Committee on Georgia Legislative Session.

The Technical College System of Georgia Foundation has disbursed funds to the college foundations for the last mile fund for Spring term.

Mr. Matt Dollar discussed the progress on non-credit standardization and Badgr. He also let the committee know that they completed the SKILLS USA competition in March.

Mr. Scott McMurray introduced Ms. Danetha Belk to the Board. She is the new Executive Director of Operation for Georgia Quick Start.

MOTION: Mr. Carvel Lewis made the Motion for the State Board to authorize the Commissioner to purchase the designated items or execute the requested contracts for the technical colleges listed below at a cost not to exceed the amounts stated. Mr. Randall Fox seconded the Motion. The Motion passed State Board approval unanimously.

 Athens Technical College – Replacement monitors and switches from CDW-G for multiple campus locations and new Industrial Technology Building; cost \$194,608.00. Obsolete equipment and FF&E bond funds are available for this expenditure.

DISCUSSION: 1) Recent computer purchases were not accompanied by monitor replacements. This purchase includes 500 monitors to replace aging, smaller monitors in both classrooms and staff/faculty offices throughout



campus locations. This purchase will update a sizable portion of ATC's monitor inventory.

2) This purchase includes 10 new switches for the main campus to replace switches that were purchased in 2013 and have reached end-of-life and are starting to fail. This represents the first step in a refresh cycle to replace end-of-life switches. These switches will offer better top data transfer speed and ensure network connectivity and support the goal of 100% uptime for the school.

3) 10 network switches are also needed for the new Industrial Technology Building that is currently under construction and set for material completion in August 2023.

2. Chattahoochee Technical College – Precision 3660 Tower PC's from Dell for all campus locations; cost \$705,861.00. Local funds are available for this expenditure.

DISCUSSION: 650 Precision 3660 Tower PC's are needed to replace the 10 year old Precision T1700 computers in classrooms/offices at all campus locations. All programs, classrooms, computer labs, conference rooms and offices that are still using the old PC's will be upgraded and benefit from this purchase.

3. Coastal Pines Technical College – Surgical Operating Room Lighting System, and Surgical Laparoscopic System w/display and boom/arm from Stryker Communications to support Surgical Technology Program; cost \$209,506.00. Obsolete equipment bond funds are available for this expenditure.

DISCUSSION: This purchase of new surgical lights, boom, and laparoscopic equipment will enhance experiential learning for students in the Surgical Technology Program by providing them laboratory simulation training using more technological up-to-date surgical equipment. This will better prepare them for their clinical sites where this technology is already available and in use with the surgical setting. This purchase is for replacement equipment since major parts of the light system and laparoscopic scope are in disrepair. In addition, the overall light system and boom are technologically outdated.

4. Southern Regional Technical College – Replacement furniture from Jasper Seating for three campus locations; cost \$227,644.00. Federal grant funds are available for this expenditure.

DISCUSSION: This purchase is to replace old/worn furniture in the common areas (hallways, lobby's, admissions, etc.) of the Moultrie, Tifton, and Thomasville campuses. These areas have had the carpet replaced and been



re-painted. The new furniture will bring a more modern and clean appearance to the improved areas. This purchase includes benches, armless/lounge seating, and linking tables.
